Sign up Sheet Instructions

SIDE 1 – HEADING

The school processor will affix the school's identification label for processing, if available. Parents check the box indicating if this is a **new** survey, or a **change** to current information already submitted.

SIDE 1 – INFORMATION

Please complete all information fields (1-13) to process your **Metro School Pool matchlist**; one (1) form for each child wishing to participate. The information you provide is used for ridesharing purposes only. Home addresses are never disclosed.

1. Parent's or guardian's full name (**Last Name, First Name, Middle Initial**)
2. Child/student's full name (**Last Name, First Name, Middle Initial**)
3. Check one only, student gender box (**F**)emale or (**M**)ale
4. Fill in the school grade your child is currently enrolled in: **K, 01, 02, 03...12**
5. Complete the home address information with the student's pick-up and return location, including: **Number, Street and Apartment Number, if applicable** – post office box numbers cannot be processed.
6. Fill in full **City Name**, and
7. The 5-digit **Zip Code**
8. Give us the closest "major" street intersection to the home. **Provide both intersection street names (example: Main/1st)**
9. Parent/guardian **contact phone number** – home or office or cellular is acceptable; this number will appear on others' matchlists.
10. Student campus hours – **preferred arrival and leave time** (no military time please). Be sure to include before and/or after school campus activities in the times given.
11. If available, give us the student's Homeroom Teacher's name (**Last/First**). This will be used for distribution of matchlists at schools when necessary.
12. Tell us how the child typically gets to school; check most appropriate answer. Metro uses this for general commuting information only.
13. Select your carpooling preferences: are you
 - ✓ Interested in sharing driving responsibilities with other parents?
 - ✓ Driving daily to provide rides to other students? – or,
 - ✓ Receiving rides for your child only, and unavailable to drive.

SIDE 2 – RELEASE

Fill in the blanks with your child's name, address, and the name of his/her elementary, middle or high school. **Review and complete the signature blocks for each parent, if applicable.** We are unable to process matchlists without parent/guardian release.

We understand that participation in the Metro School Pool Program ("Program") is purely voluntary and there is no obligation for us to participate in this Program. We are interested in identifying families living near us with a child/children attending the same school as our child so that we can make our own arrangements to carpool. We understand that the Program provides information only and that no drivers, vehicles or insurance is provided through the Program. Further, we understand that the School/School District and the Los Angeles County Metropolitan Transportation Authority ("Metro") will not perform background checks on potential drivers. We are responsible for arranging and entering into any carpools from the Program.

In consideration for participating in the Program and receiving the carpool information, the undersigned, on behalf of himself/herself and for the child listed above, hereby releases and fully discharges the School/School District and Metro and their respective employees, agents, or representatives, from any and all claims, demands and causes of action the undersigned or the child listed above, now or in the future, may have for all damages arising directly or indirectly from the undersigned's use of the carpool information provided by Metro and the undersigned's participation in the Program, and for consequential damages of every kind and character resulting from the Program, whether such damages now exist, or become existent in the future, whether the damages are known, or unknown, and whether the damages are now anticipated or unanticipated.

The undersigned relinquishes and waives all rights conferred upon it by the provision of California Civil Code Section 1542, which reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known to him must have materially affected a settlement with the debtor."
